In compliance with the provisions of Colorado Revised Statute 1-5-205(1), notice is hereby given that a Primary Election will be held on Tuesday, June 30, 2026, from 7:00 a.m. to 7:00 p.m.

Ballots will be mailed to all eligible electors beginning on June 8, 2026. Voters who do not receive a ballot by June 17, 2026, may request a ballot from Douglas County Elections, 125 Stephanie Place, Castle Rock, CO 80109, 303-660-7444.

Completed ballots may be returned by U.S. MAIL or hand delivered to a Douglas County BALLOT DROP BOX LOCATION or VOTER SERVICE AND POLLING CENTER. If you choose to return a completed ballot by mail, you must affix adequate postage to the OFFICIAL BALLOT RETURN ENVELOPE before mailing. Ballots must be received by the Douglas County Elections Office no later than 7:00 p.m. on June 30, 2026. Postmarks do not count as a received date.
