**NOTICE PROVIDING PROPOSED FORM OF RECALL PETITION;
AND REQUEST FOR APPOINTMENT OF DESIGNATED ELECTION OFFICIAL
WHO SHALL PERFORM THE DUTIES SET FORTH FOR THE RECALL**

The Recall Petition Committee ("Committee"), through counsel, submit this Notice Providing Proposed Form of Recall Petition; and Request for Appointment of Designated Election Official Who Shall Perform the Duties Set Forth for the Recall.

1. Pursuant to C.R.S. § 32-1-909(2) the proposed form of a recall petition shall be filed with the Court. Attached as **Exhibits A through E** are the proposed forms of a recall petition for the 5 current members of the board of directors of the Two Bridges Metro District.

2. Within five business days of receipt of the proposed form of recall petitions for special district directors, the Court shall issue an order appointing a designated election official who shall perform the duties set forth for the recall. C.R.S. § 32-1-909(2).

3. If the District is unable or unwilling to appoint a designated election official, the Douglas County Clerk & Recorder has a process in place to accept appointment as the designated election official for metropolitan district recall elections.

WHEREFORE, based upon the foregoing, the Committee respectfully requests this Court to enter an Order within five business days from the receipt of this Notice, ordering the following:

1. The Court has received the proposed forms of a recall petition for the 5 current members of the board of directors of the Two Bridges Metro District.

2. If the District is unable and/or unwilling to appoint a designated election official, the Douglas County Clerk & Recorder is appointed as the designated election official to perform the duties set forth for the recall.
